The author team has refined the Abstract by including the research method, research objectives, and summarizing in more detail and clearly.

Abstract

This study analyzes the success of implementing a conservation village in obtaining environmental support in forest management in the Bukit Barisan National Park. This research uses a qualitative case study method, reinforced by a desk review of relevant research literature. Interviews and focus group discussions were conducted to gain a deeper understanding of how successful policy implementation was Conservation Village in economic and conservation-based community empowerment in the TNBBS area. The success of policy implementation is reviewed by analysis of marketing policies and further analysis using a matrix of environmental reactions to policy implementation. In my opinion, the author's introduction to the research background is not comprehensive enough. It is not enough to simply introduce the environmental background of the Indonesian survey area. It is necessary to explain the forest management status of the national park itself.

Author's Response

The author's team provides additional details in the introduction on the support of the national park strategy for living systems and water resources and provides details related to the current status of national park management.

Using the Field School Strategy, efforts are being made to maintain a sustainable source of livelihood in the southern Bukit Barisan National Park. This strategy aims to provide understanding, skills, and encourage farmers to implement sustainable agriculture. 


