B. Steps for designing learning media with Canva:


1. Open Canva:

Choose a canvas size that is suitable for learning media. We can choose from various sizes and templates, such as posters, banners, presentations, or infographics, as needed.




3. Add Background:

Add text that matches the content of the material. We can choose the type of font, size, color and style that suits the desired design. Make sure the text is easy to read and understand.




5. Add Images, graphics or Videos.

If we want to include images, graphics or videos, we can upload them ourselves or use those already available in Canva.








6. Add additional Effects or Elements

Canva has various features that allow us to add effects, icons, shapes and other design elements to learning media.




7. Edits and Corrections:
